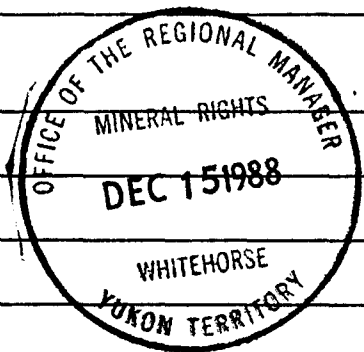

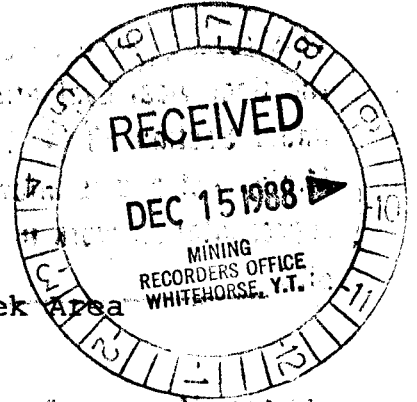



## INTRODUCTION

The area immediately northwest of the Faro Mine Site remains a prime area for economic mineral deposits because it lies along the curvilinear trend outlined by the known stratiform, massive sulphide deposits in the Anvil District (Figure 1). Previous work in this area has consisted of scattered geochemical and geophysical surveys, trenches, and drill holes completed using local coordinate grids. Precise location of previous work and future work required establishing a comprehensive and detailed orthophoto map for the area. In 1988 a 1:5000 scale orthophoto map was completed in preparation for subsequent work.

Figure 2 shows the locations of the claims with respect to the orthophoto maps. The area is mountainous with elevations ranging from 990 - 1760 m. ASL. A few dirt roads allow limited access to portions of the area by ATV and 4 x 4 vehicles. Helicopter access is provided by Trans North Air based in Ross River.

### 1979 Anvil District Survey Control

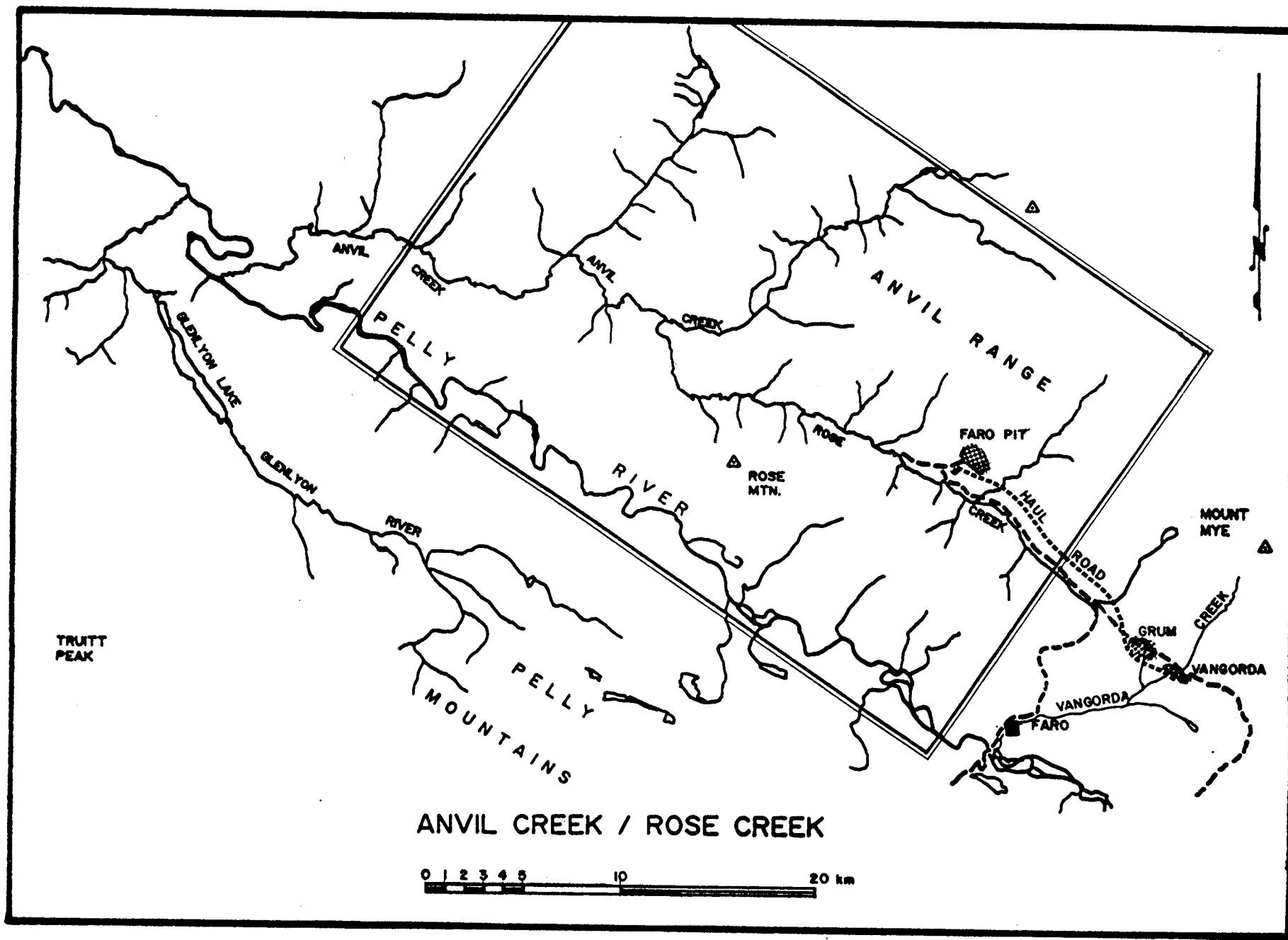
In 1979 Northwest Survey Corporation (Yukon) Ltd. completed a new control survey of the Anvil District for Cyprus Anvil Mining Corporation. The survey was undertaken to provide horizontal and vertical control for detailed orthophotos, to amalgamate all previous local control surveys to a common datum and to provide a basis for any future control surveys. All the different deposit areas were tied into a common control grid and elevation datum.

This district control survey was then tied into the international UTM (Universal Transverse Mercator) grid system using Canada Geodetic Survey Control points in the Faro-Ross River areas. The locations of these control points were adjusted in mid-1979 using satellite control. The adjusted coordinates were incorporated into the Anvil District control survey.

### 1988 Ground Survey Control

In June 1988 G. Aucoin and Associates Ltd. (legal land surveyors) extended the 1979 Anvil District Survey control into the area northwest of the Faro Mine Site. Helicopter support from Ross River was used to establish the various control points.

In addition to the photo control points, they established five permanent survey control points. The permanent control points consist of rebar anchored in the ground; they are marked with red 4 x 4 posts. Table 2 lists the coordinates for all the photo and permanent control points. The permanent control

1988 Orthophoto Map


The orthophoto mapping was completed by North West Geomatics Ltd. based in Edmonton, Alberta. The map consists of 3 contiguous sheets (Figure 3-5). All sheets were compiled at a scale of 1:5000 using 5 meter elevation contours. Permanent control points are indicated on the appropriate sheet. Photographs for the orthophoto were obtained from 1979 flight lines completed for Cyprus Anvil Mining Corporation.

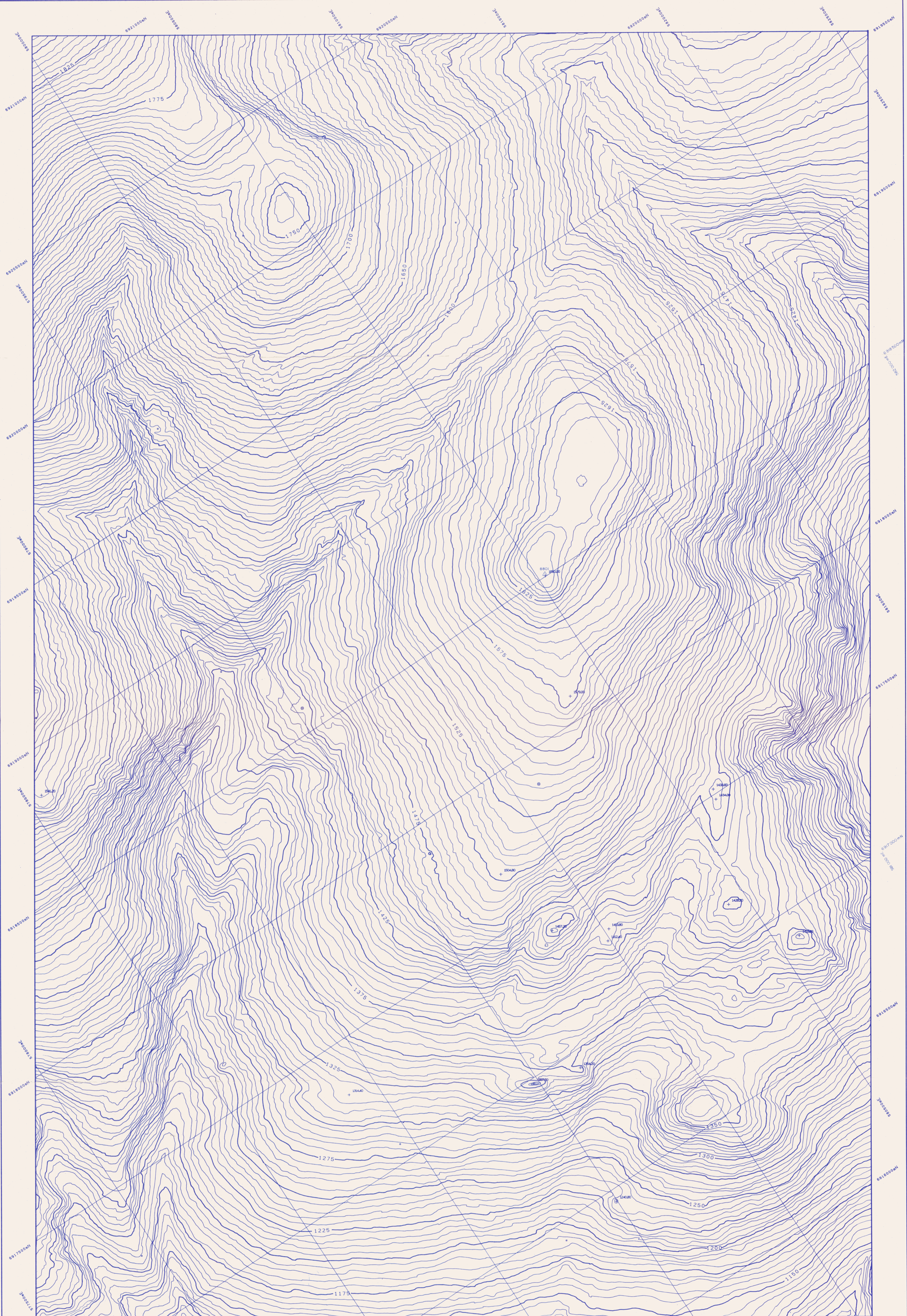

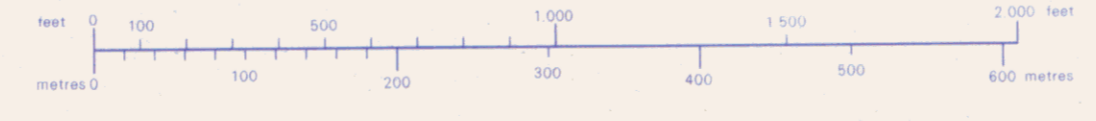
